PROGRAM:

Corporate Governance is an integral part of doing business; it provides the regulation and conditions to ensure sustained growth and lays down the framework for creating long term trust between companies and its stakeholders. Listed Companies Corporate Regulations 2019 issued by the Securities and Exchange Commission of Pakistan (SECP) requires the directors of listed companies to have certification of Directors' Training Program (DTP) with an objective to acquaint them with the regulations, applicable laws and their duties and responsibilities to enable them to effectively manage the affairs of the listed companies for and on behalf of stakeholders.

The ICAP DTP, duly approved by SECP, is a Pakistan specific five-day certificate course broadly covers essential principles of Corporate Governance, applicable laws, Business Management, Financial Management, Reporting and Communication. The Program will be conducted in two sessions of three & two days each. The program will feature presentations by professional trainers/industry experts and interactive discussions amongst the participants coupled with case studies to get the benefit from exchanging ideas and experiences with their peers.
