## Preface

The Best Corporate Report (BCR) Awards competition is the benchmark for transparency, corporate governance and excellence in financial reporting in Pakistan.

The BCR Evaluation Committee (a sub-committee of the Joint Committee of the Institute of Chartered Accountants of Pakistan (ICAP) and the Institute of Cost and Management Accountants of Pakistan (ICMAP)) has been giving the BCR Awards since 2000.

The BCR Awards aim to recognize excellence in corporate reporting and to promote accountability, governance and transparency by companies through the publication of timely, informative, factual and reader friendly information and disclosures.

Throughout its journey, the BCR Evaluation Committee remained focused on raising the bar for quality corporate reporting in Pakistan. This is done through improving the BCR criteria every year in order to incorporate all the new and updated corporate reporting and disclosure requirements on financial and non-financial information including compliance of local laws and regulations and sustainability reporting.

All public interest companies including listed/ unlisted and public-sector companies, mutual funds/ assets management companies and Non-Profitable Organizations (NPOs) are encouraged to participate in the BCR competition. The companies can participate in the BCR and BSR Awards simultaneously.

The BCR Awards are mainly classifies into two:

- Best Corporate Report (BCR) Awards; and
- Best Sustainability Report (BSR) Awards.

## Marking Criteria

BCR position and merit certificate are announced based on the below benchmark:

- a. Positions are awarded to companies securing more than 70% of the total marks;
- b. Merit certificates are awarded to companies securing more than 50% of the total marks.
- c. Annual reports containing modified auditor's report are subject to deduction up to 15 marks. This would be at the committee's discretion depending upon the nature of qualification.

## BCR Evaluation Criteria 2025

The Evaluation Criteria has always been committed to promote best practices relating to corporate reporting to improve the quality of information available to the stakeholders and also the integrated thinking within the organization.

The Evaluation Criteria is usually updated annually by the BCR Evaluation Committee to keep it in line with the international best practices and local requirements.

Key changes made in the revised BCR Criteria 2025 includes:

- A company with modified auditors report is subject to deduction up to 15 marks;
- Strengthened Risk and Opportunities areas for sustainability related risks and opportunities (Section 3);
- Disclosure of company's sustainability risks and opportunities, as required under the SECP 'Listed Companies (Code of Corporate Governance) Regulations, 2019 (amended through SECP SRO 920(1) /2024 dated June 2024);
- Addition of disclosure of Board's Policy on the following:
  - Diversity, Equity & Inclusion (DE&I) policy;
  - Anti-harassment policy.
- More emphasis on the Company's IT system and controls of the company including compliance of legal and regulatory requirements regarding data privacy and cyber security (Section 8).

## Sector-wise Winners

- a) The BCR competition provides participating companies with the opportunity to benchmark themselves amongst others in their respective sector.
- b) Total five positions are announced in each sector, subject to fulfilment of marking criteria as mentioned above, and number of participating companies in each sector.

## Overall Winners

Overall, three winners are selected based on the aggregate marks and approval of the BCR Committee.

## BCR Evaluation Process

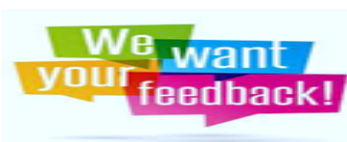
The evaluation process for the sector-winners comprises of the following:

- a) Annual reports are first evaluated by ICAP technical team, based on the updated BCR Evaluation Criteria, followed by the peer review of the BCR Evaluation Committee members.
- b) The results are presented to ICAP-ICMAP Joint Committee for approval.
- c) The approved results are announced in the BCR Awards Ceremony.

*Companies can simultaneously participate in the BCR as well as the Best Sustainability Reporting (BSR) Awards.*

### Explanatory Note

*Companies are recommended to assess the risks related to the potential theft or compromise of their technology, data or intellectual property in connection with their operations, as well as how the recognition of these risks may impact their business, including their financial condition and results of operations, and any effects on their reputation, stock price -and long-term value. Where these risks are material to investment and voting decisions, they should be disclosed, and we encourage companies to provide disclosure that allows investors to evaluate these risks through the eyes of management.*

*Further, the Company should not make such detailed disclosures that could compromise its cybersecurity efforts – for example, by providing a "roadmap or product details" for those who seek to penetrate a company's security protections. However, companies should disclose IT governance and cybersecurity risks and incidents that are material to investors, including the associated financial, legal, or reputational consequences, if any.*
